

3. Hazards Identification

This product contains an anticholinesterase compound. Do not use if under medical advice not to work with such compounds.

4. First Aid Measures

5. Fire-Fighting Measures

Suitable extinguishing media

Small ires: Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

Large ires: alcohol-resistant foam

Extinguishing media which must not be used for safety reasons: Do not use a solid water

stream as it may scatter and spread fire.

Specific hazards during fire fighting:

As the product contains combustible organic components, fire will produce dense black smoke containing hazardous products of combustion. Exposure to decomposition products

may be a hazard to health. Flash back possible over considerable distance.

Special protective equipment for firefighters: In the event of fire, wear self-contained

Further information: Do not allow run-off from fire fighting to enter drains or water courses.

Cool closed containers exposed to fire with water spray.

6. Accidental Release Measures

Personal precautions: Refer to protective measures listed in sections 7 and 8. Keep people away from and upwind of spill/leak. Beware of vapours accumulating to form explosive concentrations. Vapours can accumulate in low areas. Remove all sources of ignition. Pay attention to flashback.

7. Handling And Storage

Requirements for storage areas and containers:

Keep out of the reach of children;

Keep away from food, drink and animal feeding stuffs;

Keep away from heat and sources of ignition;

Keep away from combustible material;

Keep in an area equipped with sprinklers;

No smoking.

Other data: Physically and chemically stable for at least 2 years when stored in the original unopened sales container at ambient temperatures.

8. Exposure Controls/Personal Protection

Engineering measures: Containment and/or segregation is the most reliable technical protection measure if exposure cannot be eliminated.
